Applications are currently being accepted for Statewide Transportation Improvement Fund (STIF) Formula funds, Special Transportation Fund (STF) Formula funding (both administered through the Oregon Department of Transportation, ODOT), or 5310 Formula funding through the Federal Transit Administration (FTA) .

Please submit all completed project applications by 5pm on December 17, 2020.

STIF Application Guidance

Statewide Transportation Improvement Fund (STIF) dollars may be used for public transportation purposes that support the effective planning, deployment, operation, and administration of public transportation programs. For STIF, project applications must be submitted in accordance [with the instructions](#) and using the online form <https://www.cognitofrms.com/ODOT2/ptsprojectapplication>

Jefferson County's Statewide Transportation Improvement Fund Advisory Committee (STIFAC) will meet to review and prioritize project proposals on Friday, Jan. 8 from 2 – 3:30pm. Project applicants must be able to demonstrate the organizational, financial and managerial capacity to administer a grant in accordance with state and local laws, regulations and requirements.

STF Formula funds are distributed by lead agencies which may be a Tribe, County or Transit District. This funding is intended to support public transportation for seniors and people experiencing disabilities. For STF, project applications must be submitted in accordance [with the instructions](#) and using the online form <https://www.cognitofrms.com/ODOT2/specialtransportationfundgrantfundingapplicationfy202123>. 5310 Application Guidance

The final funding opportunity is 5310 Formula, which is a federal funding source that supports public transportation for seniors and individuals with disabilities by funding eligible capital, purchased service, and preventive maintenance projects for transportation providers. 5310 project applications must be

submitted in accordance [with the instructions](#) and using the online form <https://www.cognitoforms.com/ODOT2/section5310applicationfy202123>. Jefferson County's STFAC will meet to review project proposals during a January or February committee meeting (TBD).
