

## Jefferson County Request for Statewide Transportation Improvement Fund (STIF) Formula Fund and FTA 5310 Subrecipient Provider Applications for the 2023-2025 Biennium

Thank you for your interest in applying for Statewide Transportation Improvement Fund (STIF) formula funds and Federal Transit Administration (FTA) Section 5310 funds, administered through the Oregon Department of Transportation (ODOT).

Completed STIF Formula Fund Subrecipient Provider Applications must be submitted to Jefferson County by 5 p.m. on November 8, 2022. Applications must be submitted in accordance with the instructions and using ODOT's online form at <a href="https://www.cognitoforms.com/ODOT2/SubrecipientProjectApplication202325">https://www.cognitoforms.com/ODOT2/SubrecipientProjectApplication202325</a>. Jefferson County's Statewide Transportation Improvement Fund Advisory Committee will meet to review and prioritize project proposals after they are submitted. STIF Advisory Committee meeting notices, agendas, and minutes are posted on COIC's website at <a href="www.COIC.org">www.COIC.org</a>, as COIC was delegated to administer Jefferson County's STIF Program. Applicants are encouraged to attend STIF Advisory Committee meetings.

Before completing your STIF Subrecipient Project Application, please review the <u>Formula Fund Guidance and Application Instructions document</u> and related STIF documents posted on <u>ODOT's Funding Opportunities web page</u>. Project applicants must be able to demonstrate the organizational, financial and managerial capacity to administer a grant in accordance with state and local STIF and Special Transportation Fund (STF) programs were consolidated in January 2022 to increase efficiency and funding reliability for public transportation providers throughout Oregon. STIF funding may be used to finance investments and improvements in public transportation services, except for light rail capital expenses. STIF may be used for public transportation purposes that support the effective planning, deployment, operation, and administration of public transportation services and programs. STIF Formula Funds are not intended to supplant local funding sources to maintain existing services.

## FTA Section 5310 Application deadline extended to 5 pm on November 16, 2022

Eligible subrecipients such as counties, mass transit districts, Indian Tribal governments, Councils of government and private nonprofit organizations can also apply for FTA Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities Formula Funds.
