This measure would approve dissolution of the Madras Aquatic Center Recreation District ("MACRD") contingent upon voter approval of the formation of a new aquatic center recreation district ("New District").				
MACRD's current funding is insufficient to sustain continued District operations. State law does not permit MACRD's electors to vote on whether to increase the current permanent tax rate to fund MACRD's operations. A new park and recreation district may be formed with a new permanent tax rate subject to voter approval. Jefferson County has initiated formation of New District with a permanent tax rate limit subject to voter approval.				
New District's boundaries are identical to those of the existing MACRD. New District will provide the same or similar services currently provided by MACRD. If formed, all MACRD's operations, assets, contractual agreements, obligations, liabilities, and debts will be assigned and/or transferred to, and assumed and performed by, New District consistent with MACRD's plan of dissolution and liquidation. MACRD's plan of dissolution and liquidation is available for examination at the office of the Jefferson County Clerk.
