WHEREAS, the Board of Commissioners finds that setting new fees effective July 1, 2016, is in the best interest of the County and the public it serves.


NOW, THEREFORE, IT IS HEREBY ORDERED by the Board of Commissioners for the County of Jefferson, State of Oregon, that:
